

Alabama CEU Guidelines

- Thirty (30) CEU points are required for renewal during the three-year certification period. Most meetings are approved for 10 points.
- Obtaining CEU points does not renew your certification. Renewal notices are mailed out the first week of each month to the applicators whose certifications expire that month. In order to renew, you must submit to us a completed renewal application and the appropriate renewal fees.
- Applicators may complete only one approved online/correspondence course or video series within the three-year certification period to receive recertification points.
- Recertification points will only be awarded to applicators whose certifications are in good standing (i.e., not expired) and if the meeting attended was approved for the applicator's certification category(ies).
- Applicators must sign the roster sheet of a meeting/conference (or scan in/out, if applicable) in order to receive credit for attendance. If the meeting is approved for 20 points (i.e., multi-day meeting), applicators must sign roster sheet (or scan in/out) each day in order to receive credit.
- If you do not have enough points to renew, you may apply to take a recertification exam by signing up at <http://apply.adaitesting.com>.
- The ADAI recertification meeting list is frequently updated; the current list can be found at <http://agi.alabama.gov> under Pesticide Management-Certification and Training.
