## **IMPORTANT NOTICE**

To fall in line with the standard practices of the Alabama Department of Revenue's vehicle tag design changes, starting with 2015 license plates, actual license plates will only be issued every five (5) years with a renewal decal issued the subsequent four (4) years.

***In the following years a new license plate will be issued:***

***2015 – 2020 – 2025 – 2030 – 2035 – 2040...***

In the event a tag is lost or damaged and a replacement license plate is needed, a replacement fee of \$15.00 will be charged.

In the event a license plate is transferred from one livestock trailer to another, a transfer fee of \$10.00 will be charged.
