Section 2-25-6, Code of Alabama (1975), requires that anyone or any agency that buys and re-sells nursery stock register with the Department of Agriculture and Industries, annually. Renewals are accepted between September 1<sup>st</sup> and 30th. A \$20.00 permit fee is required for each separate place of business. Renewals after October 1<sup>st</sup> are assessed a late fee of \$3.00.

State Law requires that nursery stock be purchased from certified sources only. Please list Nursery Stock Source on following page or on a separate attachment.
